Synthetic progesten for mares.

INDICATIONS

Thermo® lis indicated to regulate estrus during the post-winter transition phase when there is an ovarian follicle measuring 15 to 20 mm, detectable by palpation or ultrasound. It should be administered for 14 days, and on day 15, prostaglandin F2 α (PG F2 α) is applied, with estrus reappearing on days 17-18.



Another indication is estrus synchronization in cyclic mares, as well as uterine tone improvement and preservation of pregnancy in mares suspected of primary and/or secondary luteal insufficiency, which should be confirmed through progesterone testing.

In cases of pregnant mares suffering from colic, endotoxemia, laminitis, pododermatitis, chronic pain, long-distance transport, among other factors, there is a potential for the release of high doses of endogenous prostaglandin F2 α (PG F2 α), leading to luteolysis and a reduction in progesterone production, along with its consequences. **Thermo**[®] is an appropriate indication for replacing the potential deficit of endogenous progesterone in these cases. **Thermo**[®] is a pharmacological tool used to suppress estrus and

Thermo® is a pharmacological tool used to suppress estrus and achieve cervical closure once ovulation has occurred, while the symptoms of heat are still present. This is particularly useful in mares or young fillies in high-level competition. **Thermo**® suppresses estrus at the beginning of it, an objective achieved 36 to 48 hours after the start of its administration. The use of Thermo® not only suppresses estrus but also stabilizes hormonal fluctuations that occur during it and mitigates the adverse effects of heat in competing fillies. Advantages over injectable progesterones include:

- l. Its use does not interfere with endogenous progesterone values (of luteal origin). Therefore, during its administration, it is possible to perform serial serum progesterone testing to detect its return to normal levels and discontinue the medication.tar su retorno a la normalidad y suspender la medicación.

COMPOSITION

COLLATERALEFFECTS

Altrenogest can increase the ventilatory response of respiratory centers to CO2, leading to a reduction in arterial and alveolar partial pressure of this gas (PCO2). It may cause drowsiness due to a certain depressant effect on the central nervous system (CNS). It can also modify insulin values.

<u>Contraindications:</u> Do not administer to males. Do not administer to females with uterine infections (endometritis).



DOSAGE

Oral route.

The dose is 0.044 mg of altrenogest per kg, once daily at approximately the same time. A 10 ml measure is the dose for a 500 kg mare, administered using a syringe, by cutting the tip of the container and following the steps as indicated below:



"It's important to avoid underdosing due to spills during administration. If necessary, **Thermo**® can be administered up to 180 days of gestation (when serum progesterone falls below normal average values: 4 ng/ml), at which point placental progesterone begins to take over.
